## WHAT DOES REVERSE MORTGAGES.COM, INC. DO WITH YOUR PERSONAL INFORMATION?

### PRIVACY POLICY

**Why?** Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

**What?** The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security number and date of birth
- Account balances and payment history
- Credit history and credit scores
- Income and assets

**How?** All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Reverse Mortgages.com, Inc. chooses to share; and whether you can limit this sharing.

## **How does Reverse Mortgages.com, Inc. protect my personal information?**

To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings. We limit access to authorized staff and contracted service providers.

## **How does Reverse Mortgages.com, Inc. collect my personal information?**

We collect your personal information, for example, when you

- provide your contact information or other information related to qualifying for a loan
- provide your financial account information

We also may collect your personal information from others, such as credit bureaus or other companies.

## **Why can't I limit all sharing?**

Federal law gives you the right to limit only

- sharing for affiliates' everyday business purposes—information about your creditworthiness
- affiliates from using your information to market to you
- sharing for nonaffiliates to market to you

Additionally, when you are no longer our customer, we continue to share your information as described in this notice.

State laws and individual companies may give you additional rights to limit sharing. See below for more on your rights under state law.

<b>Affiliates</b>	Companies related by common ownership or control. They can be financial and nonfinancial companies. Reverse Mortgages.com, Inc. has no affiliates.
<b>Nonaffiliates</b>	Companies not related by common ownership or control. They can be financial and nonfinancial companies.
<b>Joint Marketing</b>	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. Reverse Mortgages.com, Inc. does not jointly market.
